Agenda Item 272 SCC Boundary Review

Draft response to the consultation is as follows:

"The Commission proposes to reduce the number of Councillors in Suffolk from 75 to 70.

However, the predicted growth of the population means that councillors' workloads will be increasing. In that light, we feel it would have made more sense to increase or maintain the number of councillors in Suffolk rather than decreasing it.

We also have concerns over the quantity of parishes within each division and the workload that will entail. Although the make-up of rural divisions has always differed from urban ones, the difference is now even more marked as divisions have increased in size. The proposed division of Cosford, for example, holds 20 parishes. We question how a councillor can effectively do the workload pertaining to 20 different parishes, including attending 20 meetings, when a councillor in Great Cornard (for example) need only concern themselves with one.

The geographical distance between villages in some divisions is also of concern, for example in the proposed division of Clare the distance between Wixoe in the south west and Bradfield St George in the north east is 21 miles. If we return to the pre-Covid system of face-to-face meetings we pity the poor councillor who has to drive for 40 minutes between the two to attend meetings scheduled on the same evening.

In other proposed divisions the collection of parishes does not always complement each other. The proposed division of Constable is one example: villages such as Wissington in the west are not natural neighbours to villages such as Bentley and others east of the A12; they have little in common geographically or historically.

The draft recommendation for Newton is that it falls within the electoral division of Stour Valley; this is satisfactory to Newton Parish Council as it sits comfortably with other parishes within that division (Assington, Leavenheath, Bures St Mary, Great Waldingfield, Little Cornard, Acton and Chilton)."

As reported, Tony Langley has inspected the Village Sign and due to the rotten wood is unable to refurbish the sign.

Bus Shelter at Links View

Following discussions with SCC's Transport Development Manager for Passenger Transport, Simon Barnett, the following points have been established for the replacement of the bus shelter by Links View:

- There is no funding available from Simon's budget towards the costs of replacing the bus shelter. However, James Finch is prepared to offer £1,000 of his Locality Budget towards the scheme. NPC has also applied for a £500 Locality Awards from Lee Parker's budget.
- The existing bus shelter is 3.25 metres by 1.40 metres with the concrete foundation approximately the same dimensions. Until the existing bus shelter is removed, there is no way in ascertaining the condition of the concrete foundation of the shelter which is probably 40 years old. It is worth noting that the old foundation is raised above the pavement so there will be disabled access considerations in incorporating this into a new bus shelter.



- Simon has suggested that the new shelter could be:
 - o located closer to the A134 with a path from the pavement to the new location or
 - providing a path from the existing location to the kerb

Both of these options will stop the practice of passengers walking on the road in Links View to avoid walking over wet grass to access and exit the bus. These options will require the permission of the Newton Green Trust.

• There are a number of wooden bus shelter options from SCC's preferred supplier Littlethorpe (https://www.bus-shelters.co.uk/) but as a pricing comparison should you choose the Great Leigh shelter (2.48 metres by 1.28 metres), which is the one installed opposite the Saracens, the price will be £6,980 plus delivery of approximately £650 not including installation. The shelter opposite the Saracens was manufactured by Littlethorpe and has not had any maintenance issues to date. Elsewhere in Suffolk, Simon estimates the longevity of their bus shelters is at least 20 years.

- If SCC are commissioned to undertake the project on NPC's behalf they have indicated for budgetary purposes that £6,000 would cover the removal of the old shelter, making good old base or constructing a new one plus link path to the kerb, and installation of bus shelter.
- Total budgetary costs at this point, without any detailed investigation of the site(s), are:

Bus Shelter £7,630Foundations and installation £6,000.

• With £1,500 likely to be received from our county and district councillors Locality Budgets, NPC has an Earmarked Reserve of £12,000 for Asset Replacement.

The next stage of the process will be to firm up on the costs of the project by specifying what option(s) you want considered for the quotation.
