
Agenda Item 167 Dispensations

Agenda Item 170 Proposals for land next to Recreation Ground

Mrs Clare Green, daughter of the owner and Stuart Davis of Optimum Architecture Ltd will present their proposals for developing the land next to the Recreation Ground along the A134. Stuart Davis has prepared the following plan and summary ahead of the meeting:



Good evening,

I represent the landowner, Mrs Estelle Elliott-Wilson, and her daughter Mrs Clare Green, with me this evening.

Mrs Elliott-Wilson has instructed me to engage with the community about the future potential use of this land. The field is currently contracted out and farmed by others. The area concerned is the north part of this field. It is to the south of Assington Road and east of the playing field adjacent to the Village Hall and to the west of the existing ex Local Authority houses on the south side of Assington road.

Our aim is to find a jointly beneficial use for the part of the field adjacent that will benefit the community and realise a return for the land owner.

We have viewed the Newton Neighbourhood Plan and are familiar with the recent new housing in Newton.

Due to the success and large over subscription for the 4 new bungalows built of Church Road recently, we believe the most likely beneficial route is to work on a mixed scheme of social/affordable and market housing. But we are open to suggestions and discussions for any development type that can deliver a return for mutual benefit.

We have produced a block plan as an initial suggestion (please see the attached), but we are not wedded to this and would welcome the input of the parish Council and interested local people.

We believe this piece of land can also provide beneficial connections for foot traffic within the village, avoiding crossing and walking adjacent to the A134, as well as increasing the accessibility to the playing field, the Village Hall and to a lesser extend the Green as a whole.

We have deliberately sketched 9 dwellings, not because we are trying to avoid social housing, but to keep any potential application to a 'Minor' status that a potential application is less onerous on the reports and information required by the Local Planning Authority.

We would welcome an open discussion about what we could do on this land for benefit of both parties.

Agenda Item 171 Emails Circulated

Subject: Speed limit on A1071-A134 & proposed traffic census

Please see attached copy of my email sent to CIIIr Finch on 22 September 2021 regarding a proposed traffic census and considered 40mph speed restrictions on A1071-A134. I should be most grateful if you would kindly send copies to other relevant Newton Parish Councillors asking them for their support.

Dear Clllr Finch,

With reference to our telephone conversation of Tuesday 21st September 2021 and your initial recommendation of a traffic volume census situated on Boxford Lane (A1071) I should like to suggest to you that a suitable location for positioning the census would be just before the junction with Trott's Lane and Boxford Lane approaching eastbound from the junction with the A1071/A134. I should also like to recommend removal of the "END OF SPEED RESTRICTION" sign which in my opinion and indeed is the opinion presented to me of both local residents and trader/visitors is an open invitation to over zealous motorists to accelerate towards a perilous blind spot bend. Furthermore, I totally agree with your opinion that a 40mph speed limit should be continued from the A1071/A134 junction all the way through to the "END OF SPEED RESTRICTION" sign which is currently positioned to the east of Boxford. It is of my firm option that it would be advantageous to install a permanent "REDUCE SPEED NOW" bend sign (PHOTO TO FOLLOW) just before the junction with Trott's Lane and Boxford Lane, again, approaching eastbound from the junction with the A1071/A134. I cannot emphasise enough that the overall proportional number of reckless motorists (cars, vans, motorcyclists, OF WHICH SOME ARE VERY RESPONSIBLE, and yes, sometimes heavy goods vehicles is much too high and that inevitably further accidents and indeed fatalities will follow if nothing is done to slow the pace of traffic down. In the event of a proposed continuous 40mph speed restriction this would also save serious injury or lives with respect to fog which is very prevalent along this stretch of road during the autumn and winter months.

I have contacted Martin Richards at Gryphon First Aid Unit (who I worked with on a similar project at Long Melford), who has provided the following approximate costs:

- Defibrillator £850.00
- Rescue Kit £20.00
- Carry sleeve £30.00
- Defibrillator Cabinet (heated) £480.00 requires an electricity supply
- For a solar powered Defibrillator Cabinet £1,985
- For unheated cabinets he will do some further research.

Further to NPC's letter to the landowner of the land at Jarvis Farm, the following response has been received:

Dear Sirs

Re: Use of Permissive Footpath at Jarvis Farm

Thank you for your letter dated 9 September 2021.

In response, we confirm permission is given for use of our land as a permissive footpath only. The part of our land in question is identified and described on the plan you enclosed with your said letter and forms part of the circular walk 1. However, as part of this agreement we wish to put you on notice of the following.

We currently use the land in question to ride our horses across to gain safe access to various rides around the countryside. Please note that should our use of the land change or it become necessary to prevent access for any reason or the need arises for us to withdraw our consent, we shall give you notice.

As suggested, we would appreciate you writing to us annually to seek our permission.

Most importantly, we shall accept no liability for the footpath's maintenance nor accept any liability for any loss or injury sustained by any user of the footpath. We do not have nor look to obtain any public liability insurance in relation to the same and therefore, we seek your confirmation that you shall accept liability.

On the 5th October 2021, NPC's insurer Came & Co (Mark Alexander) has confirmed that the council are covered for public liability under this arrangement.
